Nomination papers must be delivered to the Returning Officer at the Electoral Services Office, Southend-on-Sea Borough Council, Civic Centre, Victoria Avenue, Southend-on-Sea, Essex, SS1 9SB on any day from the date of this notice on Monday to Friday 9am to 5pm (excluding bank holidays) but no later than **4pm on Wednesday, 3rd April 2019**.
3. If any election is contested the poll will take place on **Thursday, 2nd May 2019**.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on **Friday 12th April 2019**. Applications can be made online: <https://www.gov.uk/register-to-vote>.
5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Southend-on-Sea Borough Council, Civic Centre, Victoria Avenue, Southend-on-Sea, Essex, SS1 9SB by **5pm on Monday, 15th April 2019**.
6. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Southend-on-Sea Borough Council, Civic Centre, Victoria Avenue, Southend-on-Sea, Essex, SS1 9SB by **5pm on Wednesday, 24th April 2019**.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Southend-on-Sea Borough Council, Civic Centre, Victoria Avenue, Southend-on-Sea, Essex, SS1 9SB by **5pm on Thursday, 2nd May 2019**. The physical incapacity must have occurred after **5pm on Wednesday, 24th April 2019**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5pm on Wednesday, 24th April 2019**.
