LEIGH ALLOTMENTS ORCHARD GROUP Orchard Report, January 2015

Little to report this time, apart from the last work party of 2014 in mid November which was the annual grass cutting exercise. The weather was kind and there was a good attendance of group members and 90 percent of the work was completed in a morning session, the final remnants being cleared a few days later. One or two frogs had narrow escapes from the scythe blades but luckily they kept their heads down!

Just recently a new tree, a Seabrook's Red, was planted to replace the original that died suddenly last year. Needless to say the ground was a bit wet with the water table only a few inches down in some areas although a drier spot was found for the new tree. Unlike last year at this time when many of the trees had their roots in water, only one is so affected at present.

The next activity will be the annual application of fertiliser to all the trees, plus any pruning that is needed, and this will take place when the ground has dried out further.
