41. ITEMS FOR DISCUSSION

Leigh Lights SAG Meeting – 20th October 2011 – Report 1959/LLWP (Appendix 1 to the agenda)

It was **agreed** that a letter should be sent to SBC thanking them (especially Lisa Ferne and Adrian Watling), for their assistance in the planning of the event.

b) Farmers' Market Working Party – 20th October 2011 – Report 1962/FMWP (Appendix 2 to the agenda)

Members welcomed the fact that the remainder of the year dates until the end of 2012 had been agreed by SBC.
