COMMUNITY CENTRE FUNDING ISSUES

On 9 May Council resolved that:

The Council should use its own resources to set up a Community Centre Fund from:

- a) Underspends on committee budgets from 2011-2012, and
- b) Virements from committees' 2012-2013 budgets.

The Committee **noted** that the £4,387 underspend would become part of the Community Centre Fund.

The Committee **RECOMMENDED** to Finance and General Purposes that the following be vired to the Community Centre Fund

- £1,250 of the Grants to Outside Organisations
- £5,000 of the Flower Baskets Budget

a. Old Town Community Group - 23rd April 2012 (Appendix 2 to the Agenda)

b. Grant Funding Request from Old Leigh Regatta (Appendix 3 to the Agenda)

It was agreed to give a grant of £500 subject to the supply of accounts

c. Grant Funding Request from Leigh Folk Festival Association (Appendix 4 to the Agenda)

It was agreed that the Folk Festival organisers be advised of the decision to use this year's grant allocation towards the Community Centre fund but that next year the Council would be happy to discuss the use of part of the Leigh Community Centre in lieu of funding.

d. Jubilee Event - Update

In the Chairman's absence Cllr Pat Holden reported on progress. Arrangements for the Beacon had been finalised, and Leigh Lions were providing entertainment, food and a bar. Southend Borough Council had provided a grant of £500 towards the event.

Cllr Mark Bromfield volunteered to do the 1 hour fire watch on the church after the Beacon was extinguished.

A letter could be sent but as the properties were empty there was no guarantee that the owner would receive them unless the Land Registry Entry indicated another address. A Land Registry search would cost in the region of £12 per property. A letter would be prepared and delivered together with a visit by a Councillor to speak to neighbours to try to ascertain the position. Southend BC be contacted via the Cleaner Neighbourhoods Act to see if this was a way forward.
