94. BUDGET AND PRECEPT FOR 2014/15

Cllr Donald Fraser proposed that the Budget and Precept be deferred to the Extraordinary Council meeting on Tuesday. The proposal was not seconded.

The budget recommendation from F&GPC had been amended as a consequence of the omission of the Skate Park Budget from the summary adding £5,351 to the total. In order to keep the overall budget within the same region of the recommendation the proposed reserve was reduced from £70,000 to £65,000.

The amended budget was put to the vote, a recorded vote was requested.

Council **RESOLVED** to agree the amended budget.

A proposal was put by Cllr Richard Herbert; seconded by Cllr Jerry Holden.

If additional staff costs were required as a result of the Extraordinary Council meeting on Tuesday that they be taken from reserves.

A recorded vote was requested.

That a Budget of £329,581 be set for 2014/15, with a Local Council Tax Support Grant of £27,000 and a Council Tax figure of £302,581 resulting in a Band D Council Tax of £36.34 a decrease of £2.63 (6.75%) on last year.
