32. DECLARATION OF MEMBERS' INTERESTS

33. APPROVAL OF THE MINUTES OF THE MEETING OF 24<sup>th</sup> JUNE 2013

The minutes of the extraordinary meeting of 24<sup>th</sup> June 2013 were agreed as a correct record and signed by the Vice Chairman.

34. INTERNAL AUDITORS YEAR END REPORT (Appendix 1 to the agenda)

The Vice Chairman highlighted some elements of the report which contained no recommendations for action.

The Committee noted the report and referred it to the Governance and Audit Working Party.

35. MOTION (Proposed Cllr Caroline Parker, Seconded Cllr Paul Lawrence) – Reference back from Council Meeting 12<sup>th</sup> June 2013.

The right for Councillors to claim expenses for stationery, and petrol / fuel costs within Leigh – outside of normal working hours i.e.; survey work, events etc.,

Those Councillors, who don't need to claim and have ample funding in place for Council expenditure, could refrain from claiming.

Members discussed in detail the wording of the motion and how such expenses were paid. The Committee was reminded that the £85 set by SBC would be paid via the payroll system in accordance with HMRC rules.

A revised form of wording was agreed by the Committee:

Councillors could claim expenses for disbursements occasioned in carrying out the office of Councillor within the Leigh Town Council area.

Cllr Carole Mulroney called for a recorded vote:

Against the recommendation Cllr Carole Mulroney

The Committee therefore **RECOMMENDED** to Council that:

"Councillors could claim expenses for disbursements occasioned in carrying out the office of Councillor within the Leigh Town Council area".
