107. COMMUNITY CENTRE MANAGER'S REPORT

The Town Clerk advised members that a projector and screen had been installed in the Lower Hall mainly for U3A use but can also be used for the Annual Town Meeting. Modifications had been made to the rear gate to widen it for vehicular access at a cost of £333 which will come from the External Maintenance Budget, faulty lighting had also been replaced.

Website, Members felt that recent modifications to the site spoiled its clean look, the site would be reviewed and modifications made to address this issue.

108. ELSIE'S PLACE FINANCIAL REPORT (Appendix 1 to the agenda)

Members **noted** the report and that the income levels and expenditure levels were on break even, if one off costs were discounted.
