

14 QUEENS ROAD, LEIGH-ON-SEA, SS9 1BA (St Clement's Ward)

Erect single storey rear extension.

210. LOS/14/0303 SOS/14/01665/FUL

46A MARINE PARADE, LEIGH-ON-SEA, SS9 2NB (Herschell Ward)

Erect dormers to side and rear and alter elevations and form vehicle access onto Marine Parade.

57 HIGH STREET, LEIGH-ON-SEA, SS9 2EP (St Clement's Ward)

Front dormer and roof alterations to form room in roof (Amended Proposal).

No Objection subject to new roof windows meeting Conservation Area Guidelines.

212. LOS/14/0297 SOS/14/01637/FULH

89 LORD ROBERTS AVENUE, LEIGH-ON-SEA, SS9 1ND (Leigh Road Ward)

Erect single storey front and rear extension, raise roof and install dormer to rear.

Objection

This will mean the loss of a small 1 bedroom bungalow, of which there is an ever decreasing supply in the town, but an increasing need because of the increase in the number of older residents.

126 BLENHEIM CHASE, LEIGH-ON-SEA, SS9 3BT (St James Ward)

Reduce and lift crown to one oak tree (Application for works to a tree covered by a Tree Preservation Order).

No Objection subject to the work being carried out strictly in accordance with the directions of the SBC Arboricultural Officer. This is probably the only remaining tree on a site that had many; it is an attractive feature in public view.

75 ADALIA CRESCENT, LEIGH-ON-SEA, SS9 3ST (Highlands Ward)

Erect single storey rear extension (Retrospective).

57 BERKELEY GARDENS, LEIGH-ON-SEA, SS9 2TD (Thames Ward)

Proposed single storey rear and side extension with integral garage/store plus loft conversion incorporating dormers (Amended Proposal).

216. LOS/14/0304 SOS/14/01709/FULH

46 BERKELEY GARDENS, LEIGH-ON-SEA, SS9 2TE (Thames)

Demolish existing side and rear extensions and erect single storey side and rear extension, alter hip roof to form gable end and erect dormer window to rear (Amended Proposal).

Objection

The front of the side extension and the proposed change to the roof line would unbalance the symmetry of a pair of matching semi detached dwellings.

The side extension should be set back from the front of the existing building in order to appear subservient to it.
